

## RISK WARNING

Horse riding is a dangerous activity. There are risks and potential accidents specifically associated with horse riding, some of which include:

- the unpredictability of animals, especially if they are frightened, no matter how well trained they are;
- collisions with objects or other riders/horses and falls;
- physical exertion for which the rider may not be prepared; and
- triggering or exacerbating a medical condition as a result of physical exertion.

## ASSUMPTION OF RISK AND INDEMNITY

1. The rider has read and understood the above risk warning and appreciates that horse riding carries the above and other risks. The rider accepts all risks associated with horse riding, including the possibility of injury, death, loss or damage. To the fullest extent permitted by law, the rider releases Sutton Farm Equestrian Centre Pty Limited and its employees, agents and contractors from all liability, actions or claims resulting from any injury, death, loss or damage suffered by or sustained to the rider while participating in horse riding on Sutton Farm.
2. The rider understands and acknowledges the dangers associated with the consumption of alcohol or any mind altering substance before or during horse riding and agrees not to ride while affected by alcohol or any mind altering substance. The rider accepts full responsibility for any injury, loss or damage caused as a result of the consumption of alcohol or any other mind altering substance.
3. The rider agrees to obey and will comply with all rules and reasonable directions made or given by Sutton Farm Equestrian Centre Pty Limited and its representatives while on Sutton Farm. The rider agrees to indemnify Sutton Farm Equestrian Centre Pty Limited and its employees, agents and contractors against all actions, claims or demands made by any person against Sutton Farm Equestrian Centre Pty Limited in respect of any injury, loss or damage arising out of or in connection with the rider's failure to comply with any such rules and/or directions.
4. If the rider rides the rider's own horse on Sutton Farm, the rider accepts full responsibility for any injury, loss or damage caused or contributed to by the rider and/or his or her horse and agrees to indemnify Sutton Farm Equestrian Centre Pty Limited against all actions, claims or demands made by any other person against Sutton Farm Equestrian Centre Pty Limited in respect of any such injury, loss or damage.
5. The rider agrees to disclose to Sutton Farm Equestrian Centre Pty Limited any pre-existing medical or other condition that may increase the risk of the rider or any other person suffering injury, loss or damage.
